

Corona Security and Hygiene Regulations

Check-In

Participant are required to submit a written or electronic certificate of a negative test result of a point-of-care (PoC) antigen test or PCR test for the SARS-CoV-2 coronavirus infection that is not older than 24 hours.

For the following group of persons, the testing requirement for participation in events does not apply:

1. vaccinated persons who have been vaccinated with a vaccine approved by the European Union and whose last required vaccination was at least 14 days ago
2. recovered persons who can demonstrate a positive PCR test result for SARS-CoV-2 coronavirus infection more than six months ago and who have received at least one vaccination against Covid-19 with a vaccine approved by the European Union which was at least 14 days ago
3. recovered persons who have tested positive for SARS-CoV-2 coronavirus infection by PCR at least 28 days and not more than six months previously

General Rules

Please pay attention to the following regulations and rules of hygiene:

- Please keep a minimum distance of 1.5 meters from other people.
- Please always wear a mask of medical standard, covering your mouth and nose. The mouth-nose protection can be removed at your seat in the conference room, especially whilst eating and drinking.
- Please note the generally applicable cough and sneeze etiquette.
- You will find hand disinfectant dispensers in the foyers and in the toilet areas. Please use them regularly.
- Please refrain from shaking hands or hugging.
- Please note the markings and signage in the conference room, in the catering area and in the sanitary facilities and follow them.
- If you feel unwell or have symptoms of a cold, we kindly ask you to stay at home.

Specific Regulations in the Conference Area

Catering

- Self-service buffet:
 - Mouth-nose protection mandatory
 - 1.5 m distance from other people
 - Please disinfect your hands before each use at provided disinfectant dispensers and wear a mouth-nose protection when using it
 - One-way streets
- Eating possible at high tables in the foyer (3-4 persons each) or at your seat in the conference room

Exhibition stands

- Mouth-nose protection mandatory for booth staff
- Mouth-nose protection mandatory for booth visitors
- 1.5 m distance from other people
- Give aways and materials can be handed out by the booth staff only

Speakers

- No mouth-nose protection mandatory at your seat on the stage (1.5 distance from other speakers ensured)
- During cabling: mouth-nose protection mandatory
- Microphones will be disinfected between the panels
- Questions from the audience can be raised on a fixed microphone in the conference room

The instructions must be strictly followed. Disregard leads to exclusion from the event.
